You are welcome to visit your child's centre at any time to breastfeed your child. Educators will help you find a comfortable environment for you to breastfeed in.

Educators can also provide your baby with expressed breast milk by bottle.

We're committed to providing accessible early learning and care centres that meet the needs of all children and families. Kindergarten and early learning (childcare) fees

Funding for three-year-old kindergarten

Currently, the government does not fund three-year-old kindergarten, so families pay the full cost for this service. However, eligible three-year-old Aboriginal and Torres Strait Islander children, and children known to Child Protection can access free kindergarten.

Funding for four-year-old kindergarten

The Department of Education and Training (DET) provides funding for each child who attends four-year-old kindergarten. This funding contributes most of the cost of delivering the kindergarten program, but not all. Families pay fees for ECMS to meet the additional cost of providing a high-quality four-year-old kindergarten program with qualified and experienced staff.

Additionally, the Kindergarten Fee Subsidy enables eligible families to attend a 15 hour four-year-old kindergarten program at minimal or no cost.

Paying kindergarten fees

You will receive your kindergarten fee invoice via email each term. You can pay your invoice via BPay, cheque, money order or by credit card (Visa or Mastercard) on our website.

Childcare benefit and rebate

Current Child Care System (until 1st July 2018)

Under the current Child Care System, families are eligible for a childcare rebate at 50 per cent of the daily fee, up to \$7,500 per child per annum, paid directly to the centre to reduce your out of pocket expense.

Additionally, some families are also eligible for Childcare Benefit (CCB) which provides additional subsidy. If you are not already registered, we encourage you to contact the Family Assistance Office (Centrelink) to find out more.

New Child Care Package (starting 2nd July 2018)

From 2 July 2018, Australia will have a new child care package.

Under the new package the Child Care Subsidy will replace the existing Child Care Benefit and Child Care Rebate. The package will mean that child care will be more affordable for most Australian families.

You can pay your invoice via direct debit, BPay, EFTPOS and salary sacrifice.

You will be asked to complete a separate consent form if photographs or videos are to be used outside the centre for newspaper/media or external publications.
